## Safety Protocols RULES and ACKNOWLEDGEMENTS

## RULES

• Dancers must arrive dressed to dance, they must leave any street clothes and shoes spaced on hooks in hall downstairs. Hooks will be marked with stickers to observe social distancing.

• Temperatures will be taken as dancers arrive. Any dancer with a temperature above 99.5 will be asked to leave.

- Dancers must observe social distancing.
- Dancers must wear a mask for class and in the public areas of the buildings.
- There will be wipes and hand sanitizer in the classrooms and in the front foyer; please use these before and after class!
- No more than two dancers in the bathroom at one time please wait socially-distanced in the hall. The bathroom is not to be used as a dressing room.
- Dancers should bring a water bottle labeled with their name; the drinking fountain is not available.
- Food is not permitted in the building.
- The mezzanine is closed to dancers.
- Parent waiting areas are not open. Parents who must come into the building to visit the office should phone ahead if possible and observe social distancing guidelines.
- Each studio has a maximum student capacity based on size. Within each studio, students will be assigned their own space, and barre if applicable.
- Barres and high-touch surfaces will be sanitized between classes.
- Taped gridlines, stickers, and other indicators will be used throughout the building to assist with social distancing and safe storage of personal items during classes.

## ACKNOWLEDGEMENTS

• Our Ballet levels which meet more than once per week have potentially large enrollments. In order to give all of our continuing students the greatest opportunity to receive in-person dance instruction, Ballet levels 3 and up are subject to a hybrid scheduling system, where students have in-person class one or more times per week alternating with remote class on other days. You will be given special registration instructions if this applies to your dancer's schedule.

• If the need for hybrid scheduling remains in effect beyond winter break, in-person/remote schedules may be reassigned to provide in-person opportunity to late-registering or new students.

• If the Academy is mandated to return to a previous Coronavirus response phase, in-person classes will convert to remote only. Further, any teacher who must for health and safety reasons, convert to remote teaching, will be permitted to do so. By signing below, you agree

to complete the current six-week session remotely in either instance. Refunds or credits will not be issued for this reason.

• Payment must be made online in advance, through the Academy office staff.

• Once payment is made, there will be no refunds or credits except for a documented medical reason.

• Dancers or parents who willfully disregard safety protocols will be asked to leave and no refunds will be given.

• I acknowledge the contagious nature of the Coronavirus and I further acknowledge that the Academy has put in place preventive measures to reduce the spread of the Coronavirus and that the Academy cannot guarantee that I/my student will not become infected with the Coronavirus.
